1. If applying online, completed applications must be submitted by 11:59 PM EST on the last filing date.
2. If applying by mail, completed applications must be postmarked no later than the last filing date.

**POSITION EXISTS IN:** Clarkstown Central School District, East Ramapo Central School District, Nanuet Union Free School District, North Rockland Central School District, Nyack Public Schools, Pearl River School District, South Orangetown Central School District and Suffern Central School District.

Some of the agencies/departments listed above may not have vacancies or be filling their vacancies at this time.

**RESIDENCE REQUIREMENTS:** All residence requirements for this examination have been waived.

**SALARY:** The starting salary is \$60,770 annually for a 40-hour workweek with Clarkstown Central School District. Salary will be pro-rated for less than full-time positions. Salary may vary in other locations.

**WHAT THE JOB IS LIKE:** This is specialized work of a responsible nature which involves evaluating the physical condition of high school athletes and advising them how to maintain maximum physical fitness for participation in athletic competition. The work also involves providing training in preventative conditioning to coaches. The work is performed under the supervision of the Athletic Director. The incumbent may be required to work evenings, weekends and/or holidays. Does related work as required.

**MINIMUM QUALIFICATIONS:** By the last filing date, you must have: New York State Certification as a licensed Athletic Trainer in accordance with Article 162 of New York State Education Law.

**NOTE:** Any outstanding application documentation must be submitted to the Rockland County Department of Personnel no later than 10 days after the last filing date; May 14, 2023. Failure to comply with the deadlines set herein may result in the disapproval of your application; disqualification from sitting for the examination; and/or disqualification from a resulting list of eligible candidates. These deadlines are subject to change by the Rockland County Department of Personnel upon notice to a candidate.

**SUBJECT OF EXAMINATION:** There will be no written or oral test for this examination. If you meet the minimum qualifications, you will receive a rating based upon an evaluation of your training and experience against the duties of the position being tested. Candidates must first complete an examination application and submit it to the **Rockland County Department of Personnel** on or before the last filing date of **May 4, 2023**. Approved candidates will be sent a notice containing directions to a website address needed to complete a Training and Experience Questionnaire. The Training and Experience Questionnaire will be available on **June 1, 2023**, and approved candidates will be required to complete and submit this questionnaire between **June 1, 2023**, and 11:59 PM EST, **June 30, 2023**.

**NOTE:** Candidates will not be able to claim any credit for training or experience gained after the application filing deadline of May 4, 2023.

Candidates who fail to submit a questionnaire by 11:59 PM EST, **June 30, 2023**, will not receive a rating.
