Examination to be held **November 4, 2023**; Last filing date **October 5, 2023**

A \$15 non-refundable application filing fee is required. A check or money order made payable to the Rockland County Commissioner of Finance must accompany the application. Please refer to Supplement A for further information regarding the application/examination process. Applications are available at: https://mycivilservice.rocklandgov.com/exams.

- 1. If applying online, completed applications must be submitted by 11:59 PM EST on the last filing date.
- 2. If applying by mail, completed applications must be postmarked no later than the last filing date.

POSITION EXISTS IN: Village of Spring Valley.

RESIDENCE REQUIREMENTS: Candidates must be legal residents of Rockland County at the time of examination.

SALARY: The starting salary is \$25.44 per hour for a 35-hour workweek with Village of Spring Valley. Salary will be pro-rated for less than full-time positions.

<u>WHAT THE JOB IS LIKE</u>: This is work which primarily involves assisting administrative personnel in the acquisition of grant monies by researching funding sources, tracking existing grant expenditures, gathering information for grant applications and preparing necessary reports. The incumbent will be in frequent contact with representatives of funding sources to gather information relating to available grants. The work is performed under the general supervision of an administrator, but the incumbent has some latitude for independent action in order to secure funding, sometimes on short notice. Does related work as required.

In your summary of experience, you must specify the dates of your employment, the number of hours worked per week, your title, and the main duties for each. Be specific; vagueness will not be resolved in your favor. Candidates who submit incomplete applications or documentation may be disqualified.

<u>MINIMUM QUALIFICATIONS</u>: By examination date, you must have: A Bachelor's degree <u>and</u> two (2) years of paid administrative, business, or governmental experience which involved writing as a substantial portion of the work (e.g. grant writing, persuasive writing, narrative reports, technical reports, manuals, complex letters, etc.). Typical business writing experience such as the preparation of letters and memoranda will not be considered qualifying experience.

NOTE: A Bachelor's degree or higher in Business Administration, English, Journalism, Public Administration or a related field may be substituted for one (1) year of the required experience.

<u>NOTE</u>: If using college credits to qualify, official college transcripts must be sent directly from the educational institution to the Rockland County Department of Personnel at rcexams@co.rockland.ny.us no later than two (2) months after the last filing date, December 5, 2023; student transcripts are not acceptable. Your college degree and/or college credit must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized by the U.S. Department of Education/U.S. Secretary of Education. If your degree and/or college credit was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency. You can write the Rockland County Department of Personnel for a list of acceptable companies who provide this service. **This form is also available on the Rockland County website:** www.rocklandgov.com. You must pay the required evaluation fee.

<u>NOTE</u>: Any outstanding application documentation must be submitted to the Rockland County Department of Personnel no later than two (2) weeks prior to the exam date. Failure to comply with the deadlines set herein may result in the disapproval of your application; disqualification from sitting for the examination; and/or disqualification from a resulting list of eligible candidates. These deadlines are subject to change by the Rockland County Department of Personnel upon notice to a candidate.

SUBJECT OF WRITTEN EXAMINATION:

- 1. <u>Preparing Written Material</u> These questions test for the ability to present information clearly and accurately, and to organize paragraphs logically and comprehensibly. For some questions, you will be given information in two or three sentences followed by four restatements of the information. You must then choose the best version. For other questions, you will be given paragraphs with their sentences out of order. You must then choose, from four suggestions, the best order for the sentences.
- 2. <u>Understanding and Interpreting Written Material</u> These questions test for the ability to understand and interpret written material. You will be presented with brief reading passages and will be asked questions about the passages. You should base your answers to the questions **only** on what is presented in the passages and **not** on what you may happen to know about the topic.
- 3. <u>Understanding and Interpreting Tabular Material</u> These questions test your ability to understand, analyze, and use the internal logic of data presented in tabular form. You may be asked to perform tasks such as completing tables, drawing conclusions from them, analyzing data trends or interrelationships, and revising or combining data sets. The concepts of rate, ratio, and proportion are tested. Mathematical operations are simple, and computational speed is not a major factor in the test. **You should bring with you a hand-held battery- or solar-powered calculator for use on this test.** You will **not** be permitted to use the **calculator** function of your **cell phone**.
- 4. Evaluating Conclusions in Light of Known Facts These questions will consist of a set of facts and a conclusion. You must decide if the conclusion is proved by the facts, disproved by the facts or if the facts are not sufficient to prove or disprove the conclusion. The questions will not be specific to a particular field.

USE OF CALCULATORS IS RECOMMENDED FOR THIS EXAMINATION

<u>TEST GUIDE</u>: The New York State Department of Civil Service has not prepared a test guide for this examination.
