<u>RESIDENCE REQUIREMENTS</u>: Candidates must be legal residents of the States of New York, New Jersey or Connecticut at the time of application submission for the examination.

<u>SALARY</u>: The starting salary is \$43.88 per hour for a 35-hour workweek with County of Rockland. Salary will be pro-rated for less than full-time positions.

WHAT THE JOB IS LIKE: This is technical work of a complex nature involving the responsibility for the coordinating of computer system projects and the installation of a variety of equipment in a networked system including providing overall computer system support. The incumbent will also be responsible for training users as well as the troubleshooting of equipment. The work is performed under the general supervision of a higher-level administrator and work guidance (e.g. lead work) may be provided to others. Does related work as required.

When completing the application, your description of experience must specify the dates of your employment, the number of hours worked per week, your title, and the main duties for each. Be specific; vagueness will not be resolved in your favor. Candidates who submit incomplete applications or documentation may be disqualified.

<u>MINIMUM QUALIFICATIONS</u>: At the time of application submission, you must have:

- 1. A Bachelor's degree or higher in Computer Science, Information Technology, or a related field, <u>and</u> two (2) years of paid work experience which involved hands-on application, development or operation of computer programs as a major function* of the work; <u>or</u>
- 2. Possession of an Associate's degree in Computer Science, Information Technology, or a related field, and four (4) years of paid work experience as indicated above; or
- 3. Graduation from high school or possession of an equivalency diploma and six (6) years of paid work experience as indicated above.

*Major function of the work shall mean more than 50%.

TRANSCRIPTS: If using college credits to qualify, official college transcripts must be sent directly from the educational institution to the Rockland County Department of Personnel at rcexams@co.rockland.ny.us no later than ten (10) days after the last filing date, October 31, 2024; student transcripts are not acceptable. Failure to comply with the deadlines set herein may result in the disapproval of your application and/or disqualification from a resulting list of eligible candidates. Your college degree and/or college credit must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized by the U.S. Department of Education/U.S. Secretary of Education. If your degree and/or college credit was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency. SUBJECT OF EXAMINATION:

There will be no written or oral test for these examinations. Your examination score will be based on an evaluation of your training and experience. To have your training and experience evaluated, you must submit the appropriate Training and Experience (T&E) Questionnaire(s) by 11:59 PM EST, November 30, 2024. The Questionnaire(s) will be available November 1, 2024.

RATED EVALUATION OF TRAINING AND EXPERIENCE:

You will complete a questionnaire that asks for specific information on your information technology education (formal degrees, IT-related training courses, certifications) and experience. You will also be asked to briefly describe a significant achievement in each of the job's areas and to provide the name and contact information for someone who can verify your information. The information you provide about your experience will be rated against the following areas:

- 1. Computer Programming
- 2. Help Desk
- 3. User Support
- 4. Network Administration
- 5. Data Communications
- 6. Telecommunications
- 7. Microcomputer Repair

<u>IMPORTANT</u>: If your application is approved, instructions for completing training and experience questionnaire will be sent to you after the last filing date of this examination. The training and experience questionnaire will be available on the Internet, for your completion between **November 1, 2024** and **November 30, 2024**. If you do not have Internet access, please contact the Rockland County Department of Personnel at (845) 364-3737 immediately upon receipt of your approval letter. Our office will then make arrangements to have you use one of the Rockland County Department of Personnel computers.

<u>NOTE</u>: Candidates will not be able to claim any credit for training or experience gained after the application filing deadline of October 21, 2024.

Candidates who fail to submit a questionnaire by 11:59 PM EST, November 30, 2024, will not receive a rating.
