1. If applying online, completed applications and electronic payment must be submitted by 11:59 PM EST on the last filing date.
2. If applying by mail, completed applications must be postmarked no later than the last filing date accompanied by a check or money order made payable to the Rockland County Commissioner of Finance.

POSITION EXISTS IN: Rockland County Sewer District #1.

RESIDENCE REQUIREMENTS: Candidates must be legal residents of the States of New York, New Jersey or Connecticut at the time of application submission for the examination.

SALARY: The starting salary is \$25.07 per hour for a 40-hour workweek with the County of Rockland. Salary will be pro-rated for less than full-time positions.

WHAT THE JOB IS LIKE: This is skilled work of a responsible nature involving the safe and efficient operation, maintenance, preventative maintenance and minor repair of an advanced wastewater treatment plant. Employees will be required to work during emergencies, both standby and weekends, on a regular rotational basis with varied hours. The work is performed under the general supervision of the Assistant Director or their designee. Does related work as required.

When completing the application, your description of experience must specify the dates of your employment, the number of hours worked per week, your title, and the main duties for each. Be specific; vagueness will not be resolved in your favor. Candidates who submit incomplete applications or documentation may be disqualified.

MINIMUM QUALIFICATIONS: At the time of application submission, you must have: Graduation from high school or possession of an equivalency diploma and a minimum of six (6) months experience in the operation and maintenance of a wastewater treatment plant or related environment.

SPECIAL REQUIREMENTS:

1. Must meet standards of OSHA regulation 1910.134 Respiratory Protection and will be required to meet Federal, State and local standards with respect to health and safety.
2. Possession of a valid driver's license appropriate for the kind and size of vehicles to be operated.

ANTICIPATED ELIGIBILITY – AGE AND EDUCATIONAL REQUIREMENTS:

According to Civil Service Law, section 54 which became effective September 4, 2024, applicants who are within 12 months of meeting the minimum age or attaining the minimum educational requirements following the date of examination, may take the civil service exam, but will be restricted from certification until such a time that the minimum age or educational requirements are met. Candidates will be required to provide proof of qualifying age and or education within 12 months of exam date in order to be eligible for appointment from a certified list.

ALL OUTSTANDING APPLICATION DOCUMENTATION: Must be submitted to the Rockland County Department of Personnel no later than two (2) weeks prior to the exam date. Failure to comply with the deadlines set herein may result in the disapproval of your application; disqualification from sitting for the examination; and/or disqualification from a resulting list of eligible candidates. These deadlines are subject to change by the Rockland County Department of Personnel upon notice to a candidate.

SUBJECT OF WRITTEN EXAMINATION:

1. Mechanical Aptitude – These questions test your ability to identify and understand how basic mechanical instruments such as motors and gears work.
2. Safety Practices – These questions test your knowledge of basic safety practices.
3. Tools and Reading of Scales and Gauges – These questions test your ability to recognize or identify basic tools and their common uses and to make accurate readings of various types of dials, scales and gauges.
4. Elementary Chemistry and General Science – These questions test your knowledge of basic processes and concepts in chemistry and general science.
5. Understanding and Interpreting Written Material – These questions test how well you comprehend written material.
6. Basic Mathematics – These questions test your ability to use addition, subtraction, multiplication and division to solve basic arithmetic problems that might be encountered in water and wastewater treatment plant operations. Questions may also involve the use of fractions, decimals, averages, and percents.
