POSITION EXISTS IN: Rockland County Department of Health.

RESIDENCE REQUIREMENT: Candidates must be legal residents of the States of New York, New Jersey or Connecticut at the time of application submission for the examination.

SALARY: The starting salary is \$50.37 per hour for a 35-hour workweek with the County of Rockland. Salary will be pro-rated for less than full-time positions.

WHAT THE JOB IS LIKE: This is professional nursing work of a responsible nature which involves a responsibility for providing routine examinations, assessments, nursing diagnoses, therapeutic procedures, counseling, management of medical modalities and health education for clients of the Family Planning Clinic of the Department of Health. While the incumbent is expected to exercise initiative and independent judgment, s/he works under standing orders and protocols established by a physician. Supervision by the licensed physician is exercised through conferences, observation of work performance and periodic reports. The Nurse Practitioner may provide supervision to a number of ancillary personnel including a Registered Nurse, Public Health Educator, Senior Nurse's Aide and related clerical personnel. Does related work as required.

When completing the application, your description of experience must specify the dates of your employment, the number of hours worked per week, your title, and the main duties for each. Be specific; vagueness will not be resolved in your favor. Candidates who submit incomplete applications or documentation may be disqualified.

MINIMUM QUALIFICATIONS: At the time of application submission, you must have: A Bachelor's degree or higher in Nursing and satisfactory completion of a Nurse Practitioner course issued by the New York State Department of Education.

SPECIAL REQUIREMENT: Licensure and current registration to practice as a Registered Professional Nurse in New York State must be maintained throughout the course of employment in this title.

TRANSCRIPTS: Official college transcripts must be sent directly from the educational institution to the Rockland County Department of Personnel at rcexams@co.rockland.ny.us no later than ten (10) days after the submission of your application; student transcripts are not acceptable. Failure to comply with the deadlines set herein may result in the disapproval of your application and/or disqualification from a resulting list of eligible candidates. Your college degree and/or college credit must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized by the U.S. Department of Education/U.S. Secretary of Education. If your degree and/or college credit was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency. Candidates are responsible for any required evaluation fees. ANTICIPATED ELIGIBILITY - AGE AND EDUCATIONAL REQUIREMENTS:

According to Civil Service Law, section 54 which became effective September 4, 2024, applicants who are within 12 months of meeting the minimum age or attaining the minimum educational requirements following the date of examination, may take the civil service exam, but will be restricted from certification until such a time that the minimum age or educational requirements are met. Candidates will be required to provide proof of qualifying age and or education within 12 months of exam date in order to be eligible for appointment from a certified list.

ALL OUTSTANDING APPLICATION DOCUMENTATION: Must be submitted to the Rockland County Department of Personnel no later than ten (10) days after the submission of your application. Failure to comply with the deadlines set herein may result in the disapproval of your application and/or disqualification from a resulting list of eligible candidates. These deadlines are subject to change by the Rockland County Department of Personnel upon notice to a candidate.

SUBJECT OF EXAMINATION: There will be no written or oral test for this examination. Candidates who meet the minimum qualifications will receive a rating based on an evaluation of their training and experience against the background of the duties of the position. You are, therefore, asked to include in your application a summary of all pertinent training and experience in sufficient detail so that your experience may be evaluated against the duties of the position. Your application will be rated on the following items. Make sure your application and supporting documents are thorough to maximize your potential for achieving the highest score

1. Do you possess a Bachelor's degree in Nursing? (See transcript statement.)
2. Do you possess a Master's degree in Nursing? (See transcript statement.)
3. Do you possess a license issued by the New York State Education Department to practice as a Registered Professional Nurse? (Must include your license number in your application.)
4. Do you have any continuing education in the field of Nursing? (i.e. formal degree programs, in-service education, professional seminars or convocations, or other educational activities designed to help maintain and improve skills and keep abreast of the nursing field.) (Must include proof of any continuing education with your application.)
5. Do you have any paid, professional experience as a Nurse Practitioner? (Must include starting month and year and ending month and year as well as hours per week worked.)
6. Do you have any paid, professional nursing experience? (Must include starting month and year and ending month and year as well as hours per week worked.)

NOTES:

1. A resume does not substitute for the completed application but may supplement it. Month and year as well as hours per week of employment must be indicated.
2. Candidates who submit incomplete applications or documentation may be disqualified.
3. Additional information will not be accepted after training and experience has been evaluated.
4. Qualified candidates will have their names interfiled on this continuous recruitment eligible list in appropriate rank order regardless of the date when they submitted their application.
5. Eligibility for appointment of each qualified individual will be for a non-extendable one-year period from the date of eligibility.
6. The Rockland County Department of Personnel reserves the right to terminate this continuous recruitment examination at any time without prior notice.
